CIRCULAR

Dear Parent/Guardian,

Greetings from Naipunnya!!!

After remaining shut for over a year and a half due to the COVID-19 pandemic, schools in Kerala are set to reopen in November. Falling in line with the decision of the Kerala government to reopen the schools, the CBSE schools across the state also have decided to reopen schools from November 1 for classes 1 to 7 and classes 10 and 12. But at Naipunnya, we would take a decision on this based on a survey conducted among parents. The government has issued a series of guidelines for the same.

GUIDELINES AND INSTRUCTIONS FOR PARENTS & STUDENTS

- ❖ It will be with due consent of the parents/guardians, the students will be allowed to attend the classes.
- ❖ No compromise will be made in crowding at classrooms or school campus.
- ❖ If any family member tests COVID positive, students must refrain from visiting the school. Students with covid related symptoms like cough, fever, headache, throat pain, etc, primary contact with covid patients or from containment zones need not come to school. A special register will be maintained in school to monitor whether any of the students develop COVID symptoms.
- ❖ In case any student has any of the symptoms mentioned, it should be immediately brought to notice of the teachers without any hesitation or fear.
- ❖ Parents/guardians who come to drop the children to school and take them back should take extra care in not entering the school and crowding around.
- ❖ It is mandatory for everyone to wear mask full time in the campus.
- ❖ Students who avail public transport must wear double masks and should carry sanitiser during their journey.
- ❖ There will be strict restrictions on visitors. Those who become primary contacts of Covid patients should stay at home.
- ❖ It is advised that students bring their own drinking water as an extra safety measure.
- ❖ Only 3 students will be allowed in auto rickshaws on school duty.

ARRANGEMENTS MADE BY THE SCHOOL

- ❖ In the initial phase, uniform and assembly will not be made compulsory. Activities such as games, PT periods, taking food in groups will not be permitted. Students are not allowed to share their study articles, food and water in the school.
- ❖ Offline and online classes cannot be conducted simultaneously. If a student is found continuously missing the classes, an appropriate measure will be taken to bridge the gap.
- ❖ Enough air circulation will be ensured in classes.
- ❖ Student activities will be managed by considering them as different bio-bubbles. Teachers would also be a part of different bio-bubbles. If the member of a bio-bubble catches Covid, the entire group will be quarantined.
- ❖ Social health awareness classes will be given to students and teachers. The students will be reminded of displaying proper conduct following covid protocol every day. There will be a health monitoring committee in the school.
- ❖ As per the present plan, school will function on Saturdays too to make up for the losses to be suffered due to the restructuring of classes as a result of the COVID-19 restrictions.
- ❖ Sanitisers will be provided at the main entrance and in front of every classroom. All the classrooms will be sanitised every day. Masks will be made available in the school.
- ❖ Differed interval timing will be scheduled for different classes to avoid crowding of students.

As per the decision evolved during the Parents' Meet held on 23rd October 2021 from classes I to VIII, the School shall be conducting a survey among parents regarding reopening of the school through Google Forms. The link for the same is posted below. The school shall arrive at a decision based on the preference of the majority.
